## ANNUAL TUITION

(Non-Refundable)

* <u>Jr.K - 8<sup>th</sup> Grade (8:30am-to 3:00pm):</u>	\$5,400 (Oldest Child)	\$5,200 (Each Additional Child)
* <u>Jr. K (8:30am to 5:30pm):</u>	\$6,000 (Oldest Child)	\$5,200 (Each Additional Child)

- ◆ Includes all Textbooks, teaching materials, on-site activities related to your child.
- ◆ Non-Refundable
- ◆ \*Jr. Kindergarten is for children who will turn 4 by September 1<sup>st</sup>.

## ONE TIME FEES

(Non-Refundable)

**Application Fee:** \$125 per child

- ◆ Must accompany application
- ◆ Covers cost of application processing

## ANNUAL FEES

(Non-Refundable)

**Registration Fee (Due each year):** \$250 (Oldest Child) \$225 (Additional Children)

- ◆ Covers annual costs of enrollment including directories, parent and student handbooks, consumable texts, classroom supplies, awards, ceremonies, counseling programs, etc.

**Tuition Guarantee Insurance:** \$243 (Oldest Child) \$235 (Additional Children)

- ◆ Not required if tuition is paid in full by Sept 1<sup>st</sup> (September preceding the start of school)
- ◆ Required if tuition is paid in payments
- ◆ 4.5% of annual tuition
- ◆ Due in full with first payment due September 1<sup>st</sup> (September preceding the start of school)

## OPTIONAL COSTS

**After School Care:** \$7 Flat Rate Per Day

- ◆ Available from 3:05-5:30pm, M-F for Kindergarten through 8<sup>th</sup> grade only.
- ◆ Will be billed on the first of each month based upon the number of days used the previous month.
- ◆ Each account that is delinquent as of the 15<sup>th</sup> of each month will be assessed a \$25 late fee.
- ◆ Repeat delinquencies may result in you becoming ineligible to use this service.

**Hot Lunch:** \$4 Per Lunch

- ◆ Available Monday through Friday
- ◆ Flat rate of \$4 per day
- ◆ Paid for in advance on a monthly basis.

**PAYMENT INFORMATION**

Your financial obligation to the School is for the full annual tuition as stated in the *School's Handbook* and *Enrollment Contract*. The School's expenses are incurred on an annual basis; therefore, the school cannot afford to refund tuition or cancel unpaid obligations if your child is forced to withdraw during the academic year. Please read thoroughly the tuition insurance pamphlet that is included in your enrollment packet.

**Payment Options:**

1. **Payment in full by September 1<sup>st</sup> (September preceding the start of school)**  
*(No Tuition Guarantee Insurance Required)*
2. **Twelve (12) equal monthly payments of \$450; Due July 1<sup>st</sup> - June 1<sup>st</sup>**  
*(Tuition insurance required; Total amount due with first payment.)*
3. **Ten (10) equal monthly payments of \$540; Due Sept 1<sup>st</sup> – June 1<sup>st</sup>**  
*(Tuition insurance required; Total amount due with first payment.)*

**Methods of Payment:**       Check       Cash       Credit Card       Money Order

- *All payments are to be delivered to the school or mailed to: Jordan Christian Academy, Post Office Box 818, Thermal, CA 92274*

**Payment Due Date:**

- Tuition payments are due on the 1<sup>st</sup> of each month.
- A \$35 fee will be automatically charged for any returned check.

**Late Payments:**

- If payment is not received at the school by the 15th calendar day of the month in which it is due, a late fee of \$25 will be automatically charged.
- Any account that is 30 calendar days late will go into suspension and the student will not be allowed to return to school until the account is brought current, including payment of all late fees incurred.
